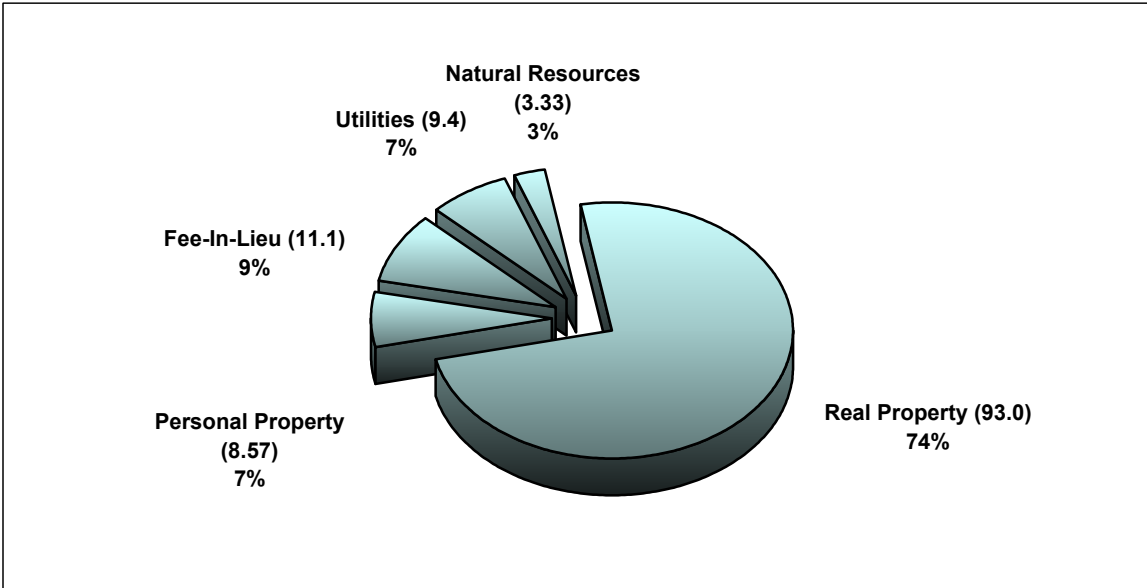


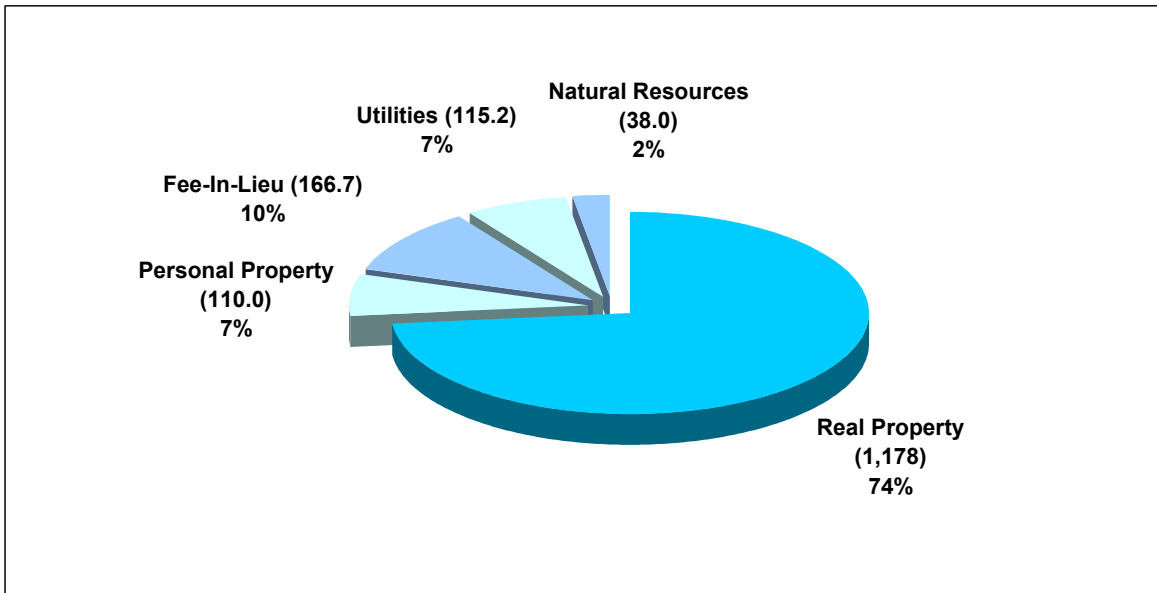

FOR 2002



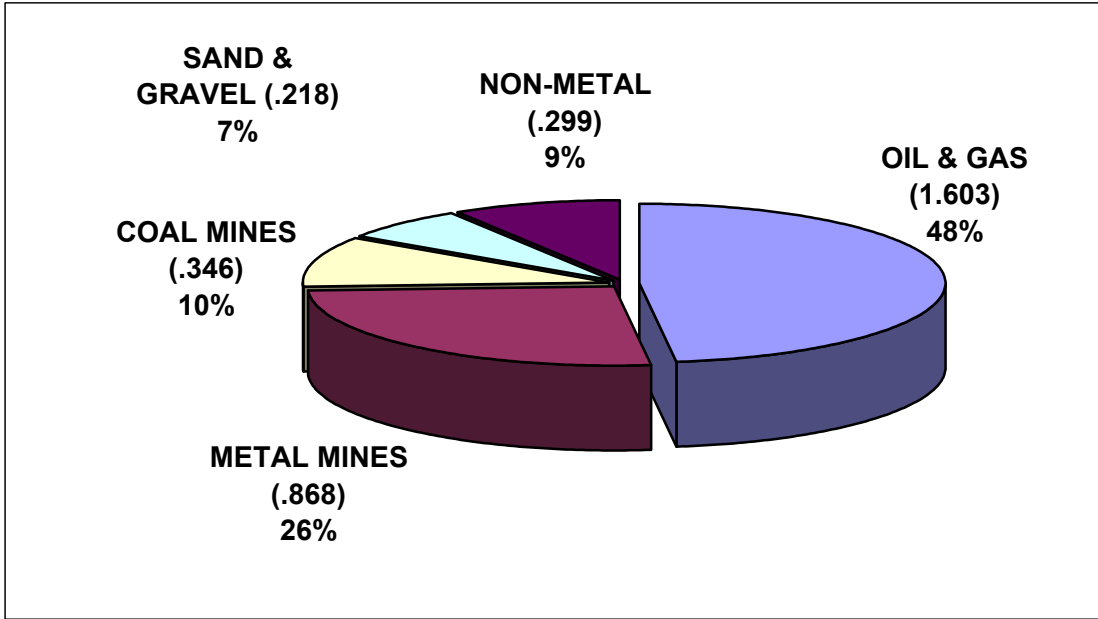

FOR 2002



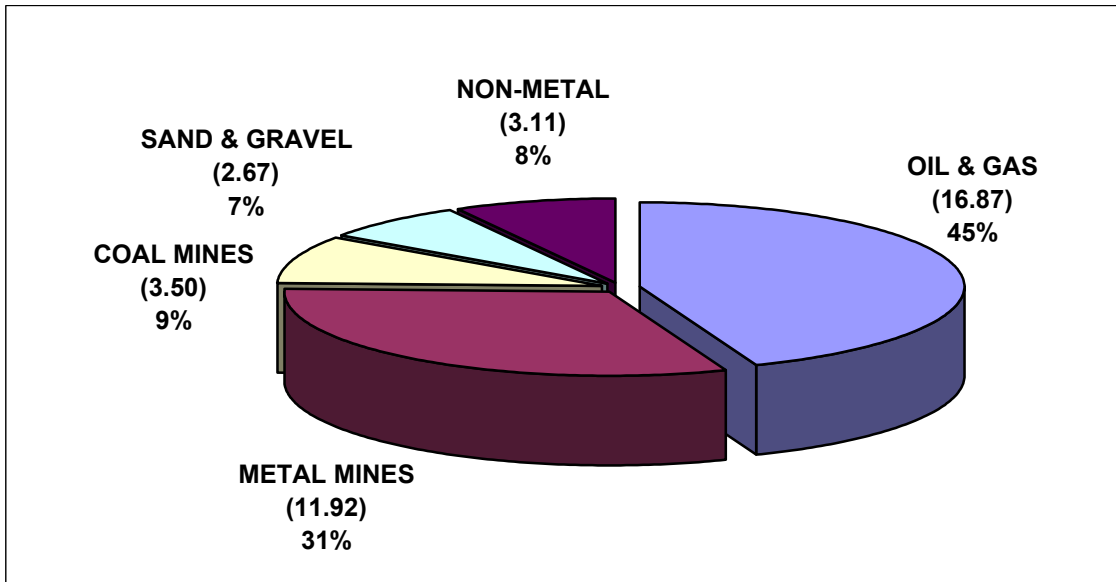

NATURAL RESOURCES



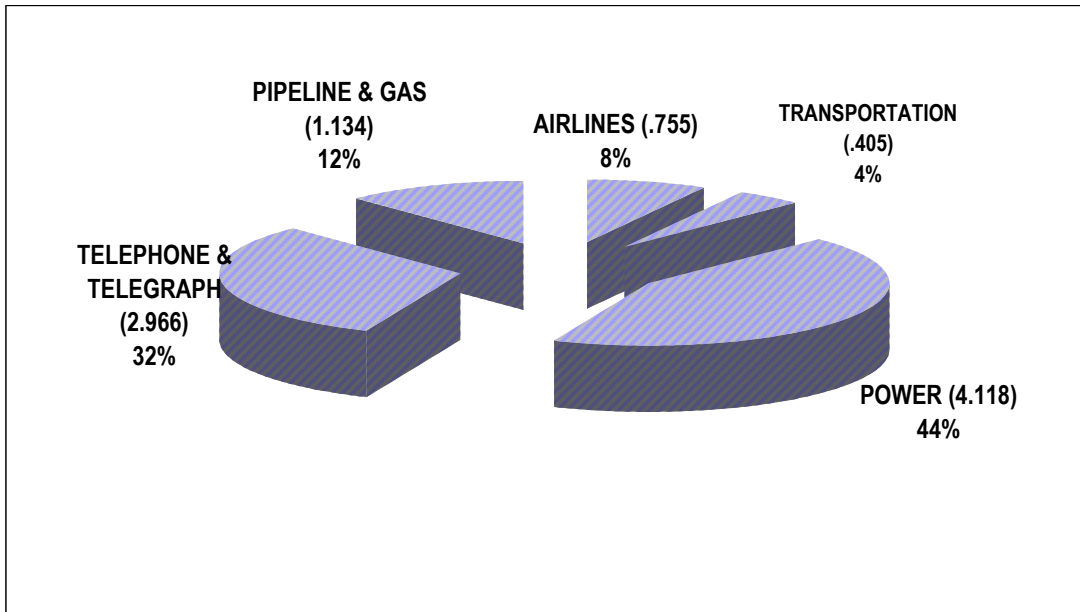

NATURAL RESOURCES



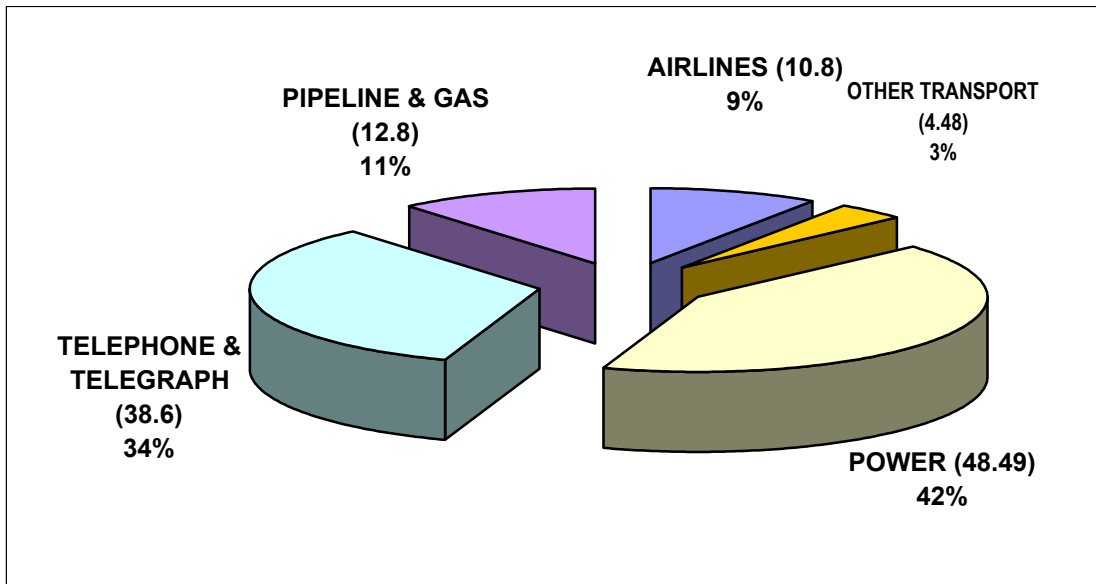

REAL PROPERTY

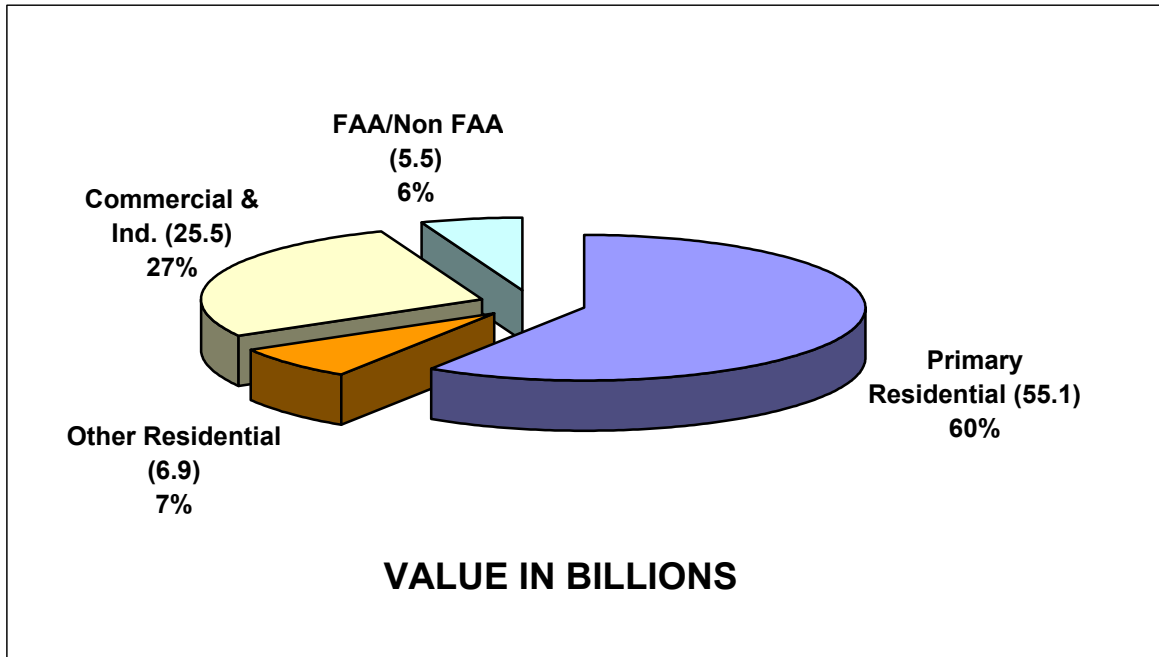

REAL PROPERTY

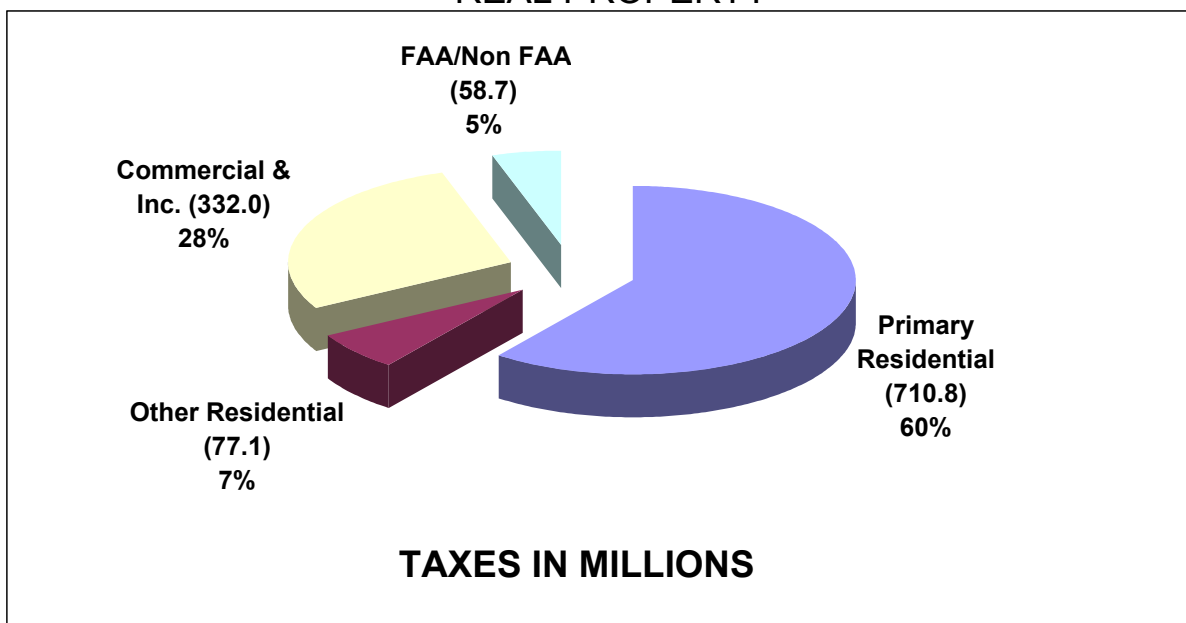

PERSONAL PROPERTY

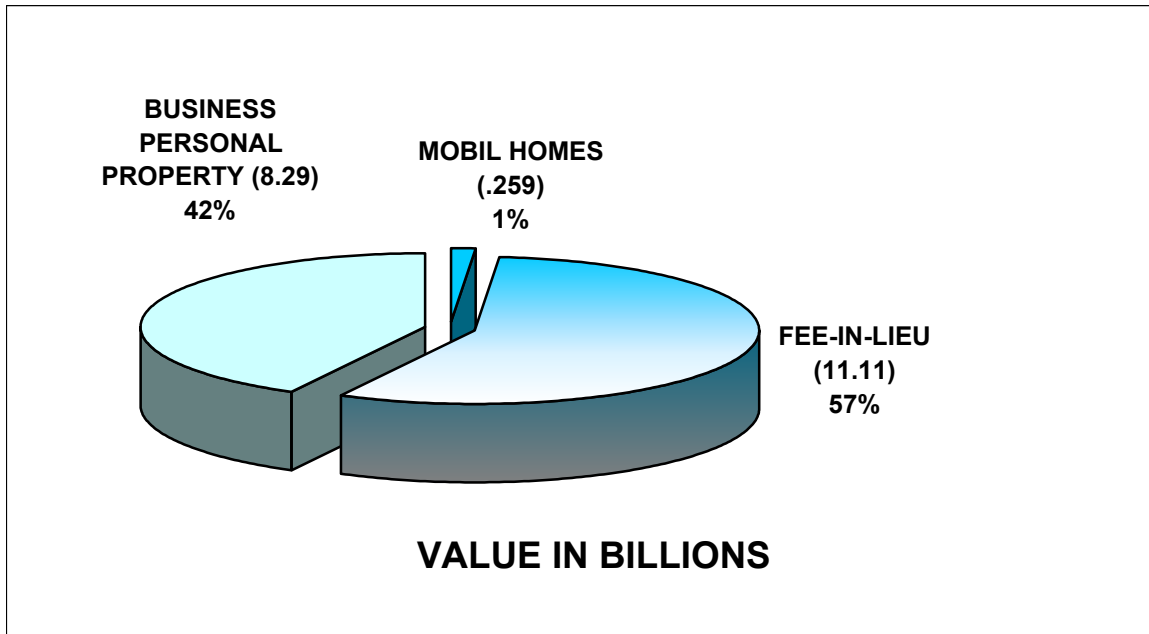
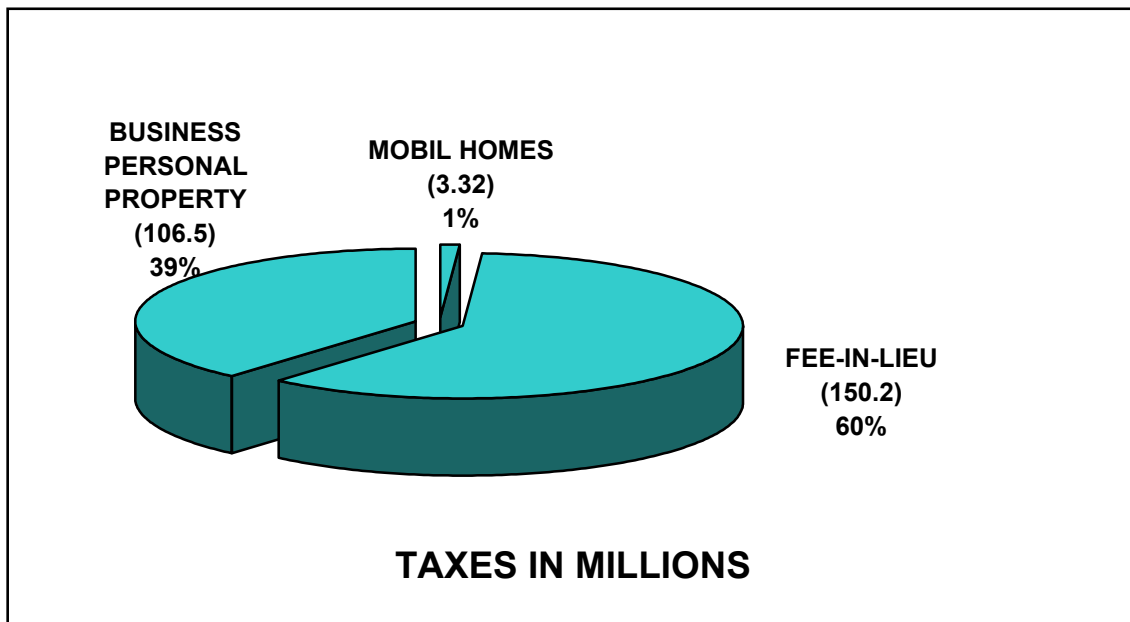

 FOR 2002**

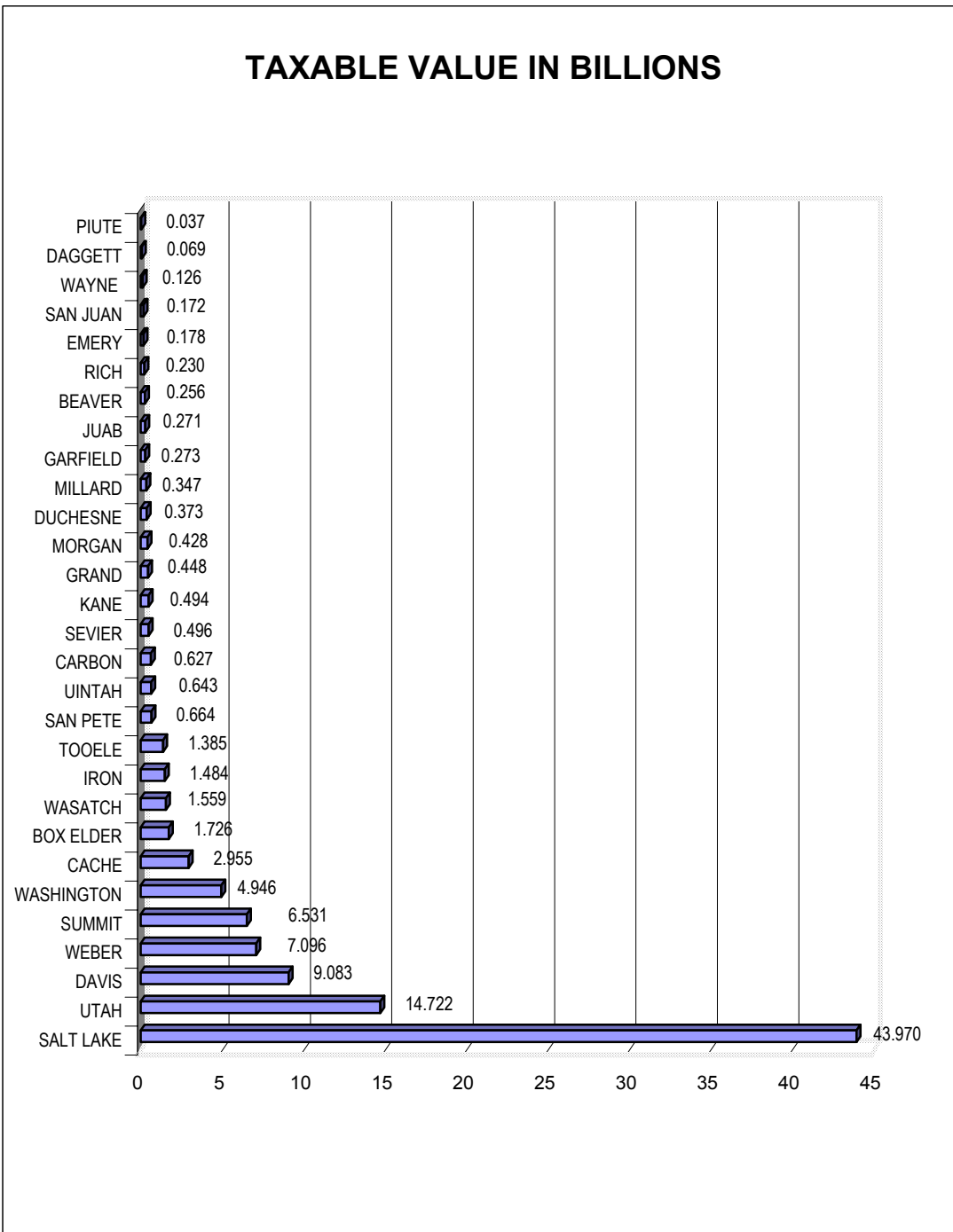

 FOR 2002

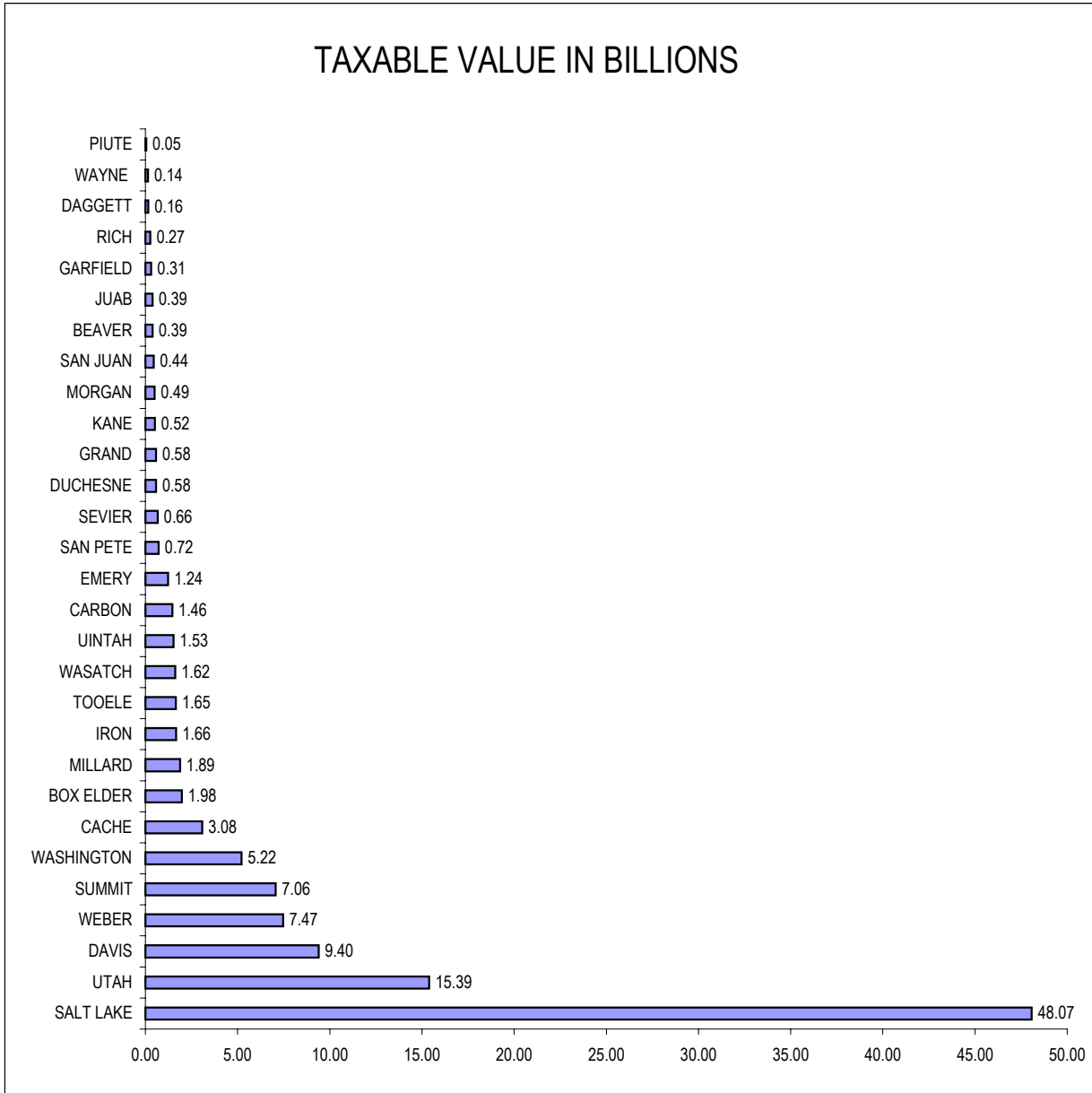

PRIMARY & OTHER RESIDENTIAL BY COUNTY FOR 2002

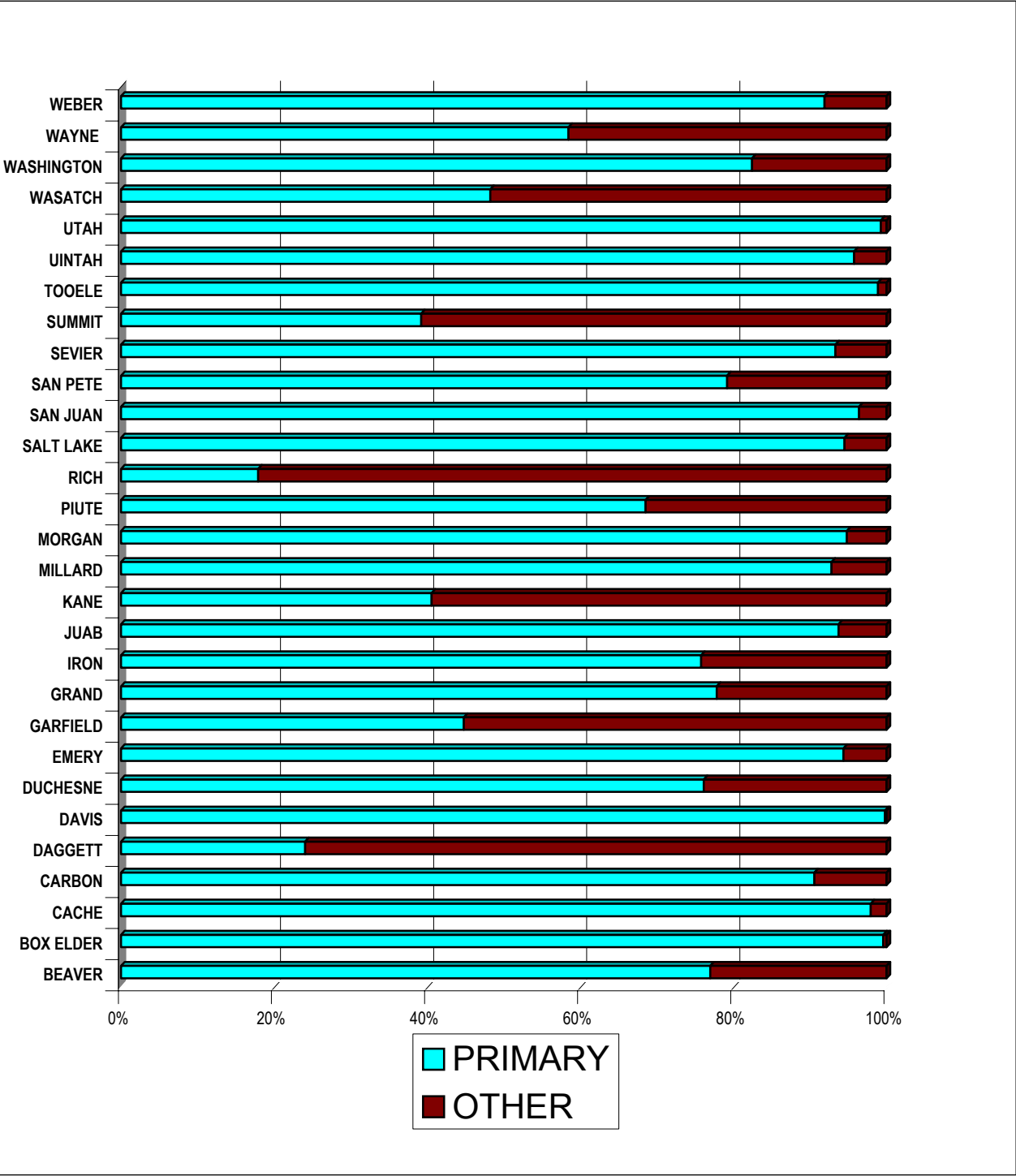

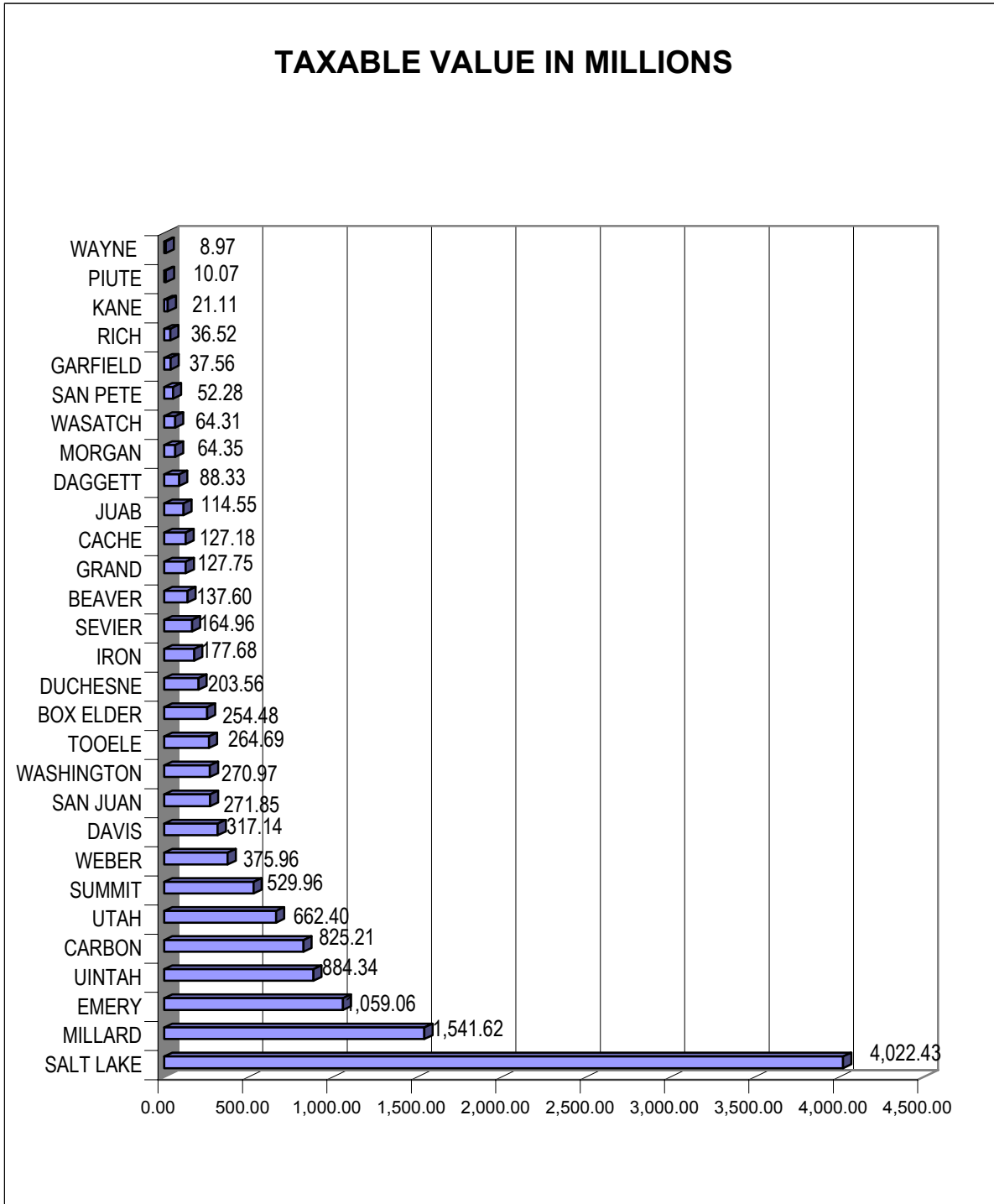

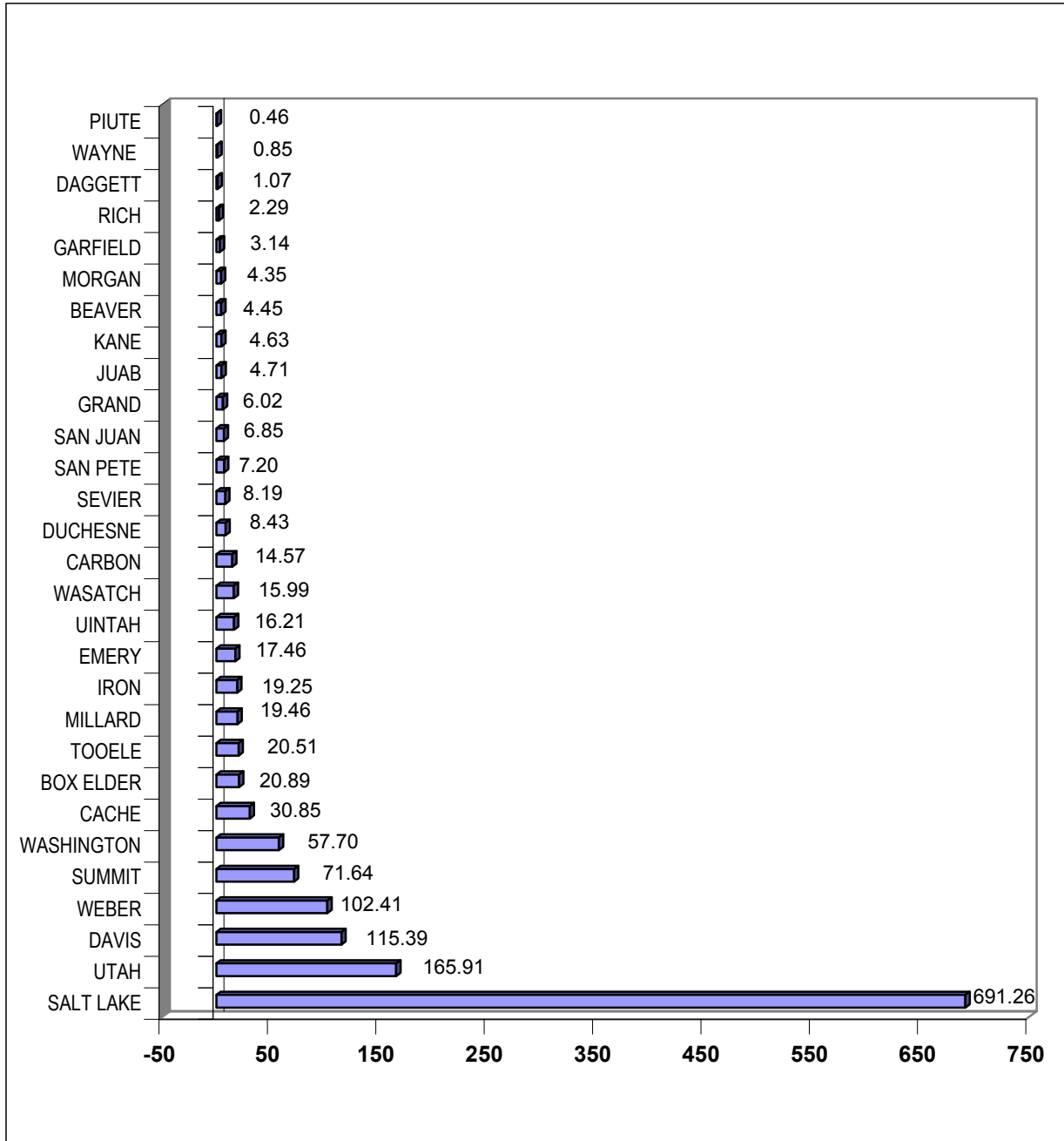

PRIMARY AND OTHER RESIDENTIAL TAXES CHARGED BY COUNTY FOR 2002

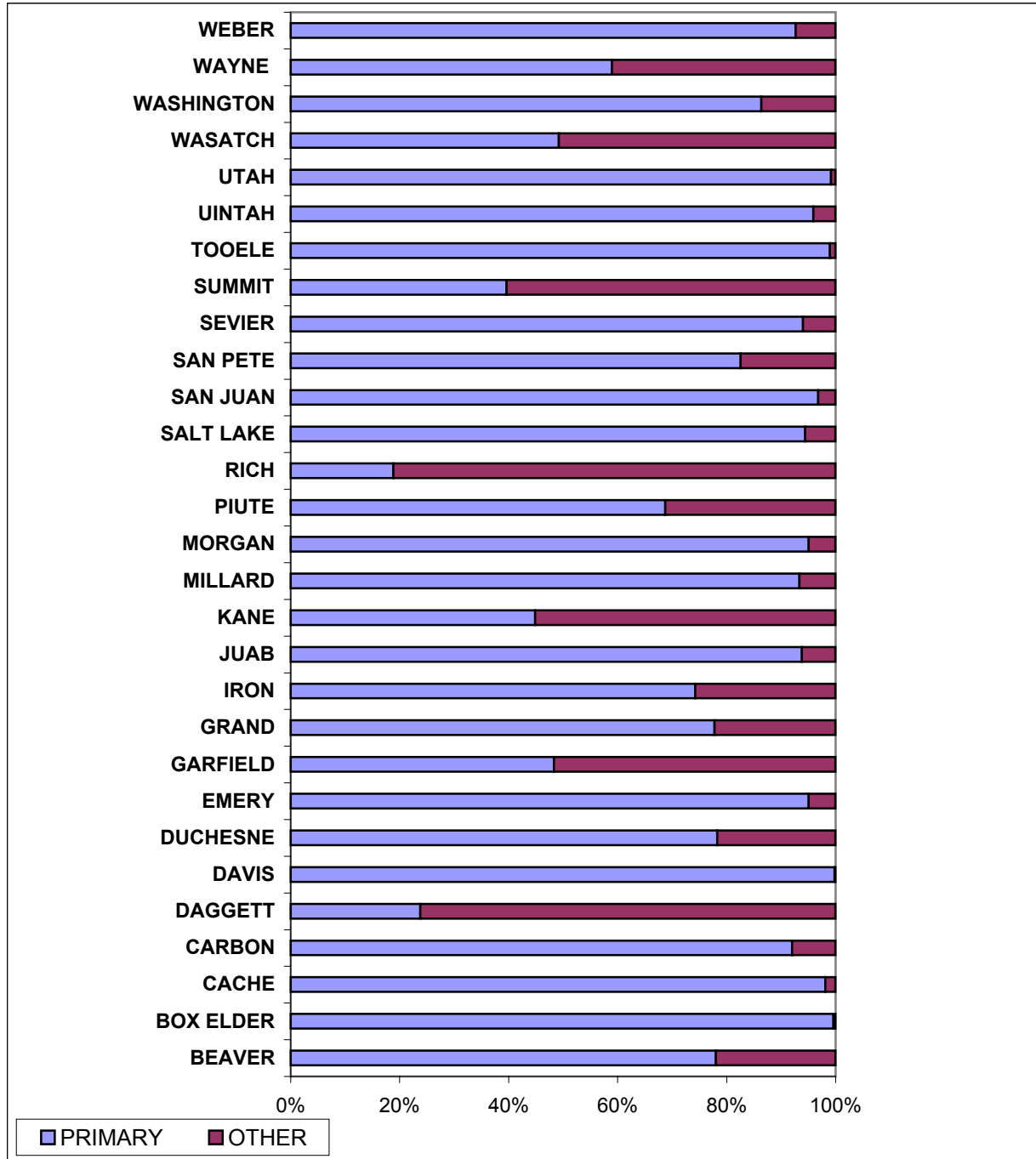

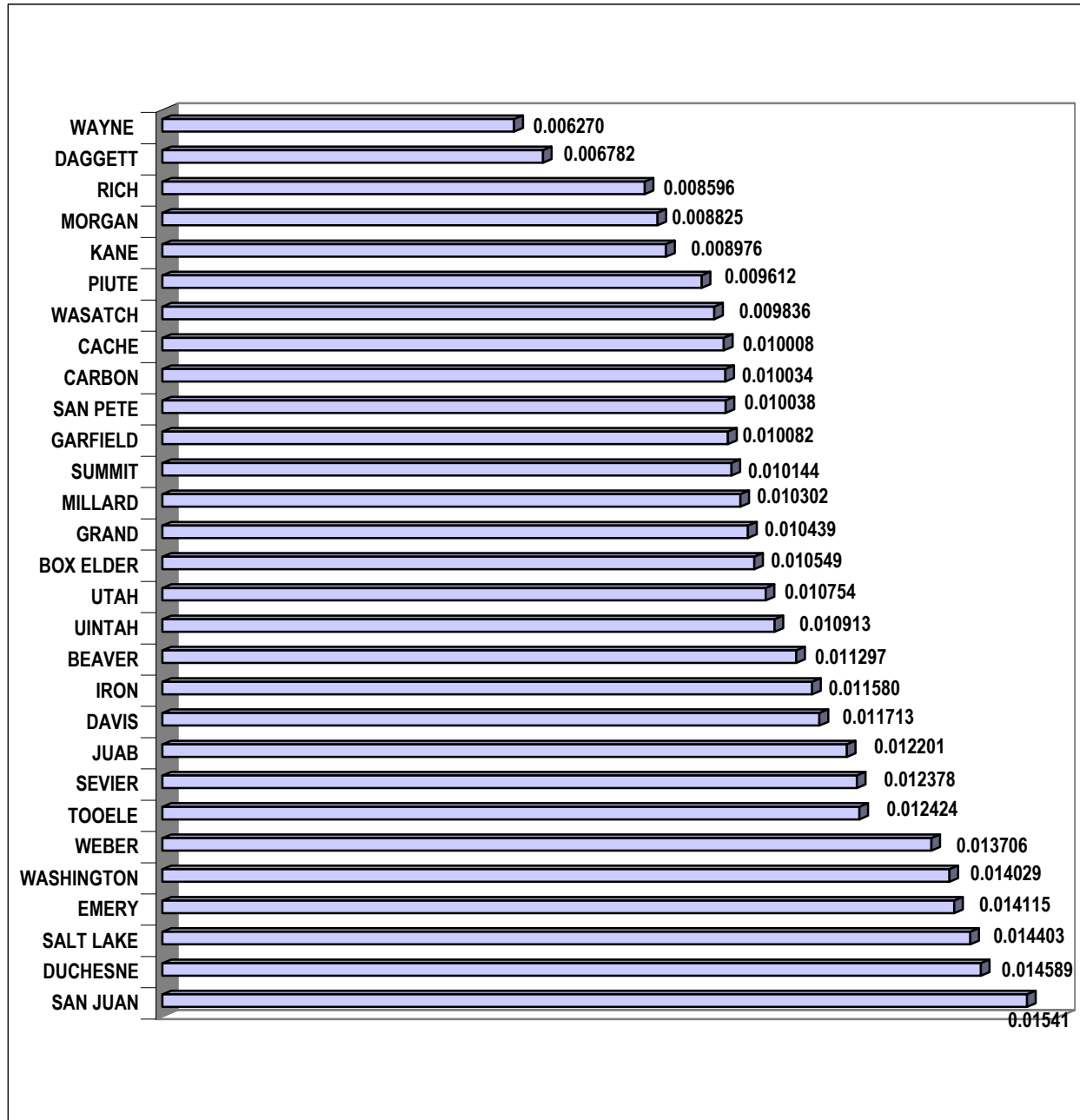

EXCLUDING FEE-IN-LIEU MOTOR VEHICLES

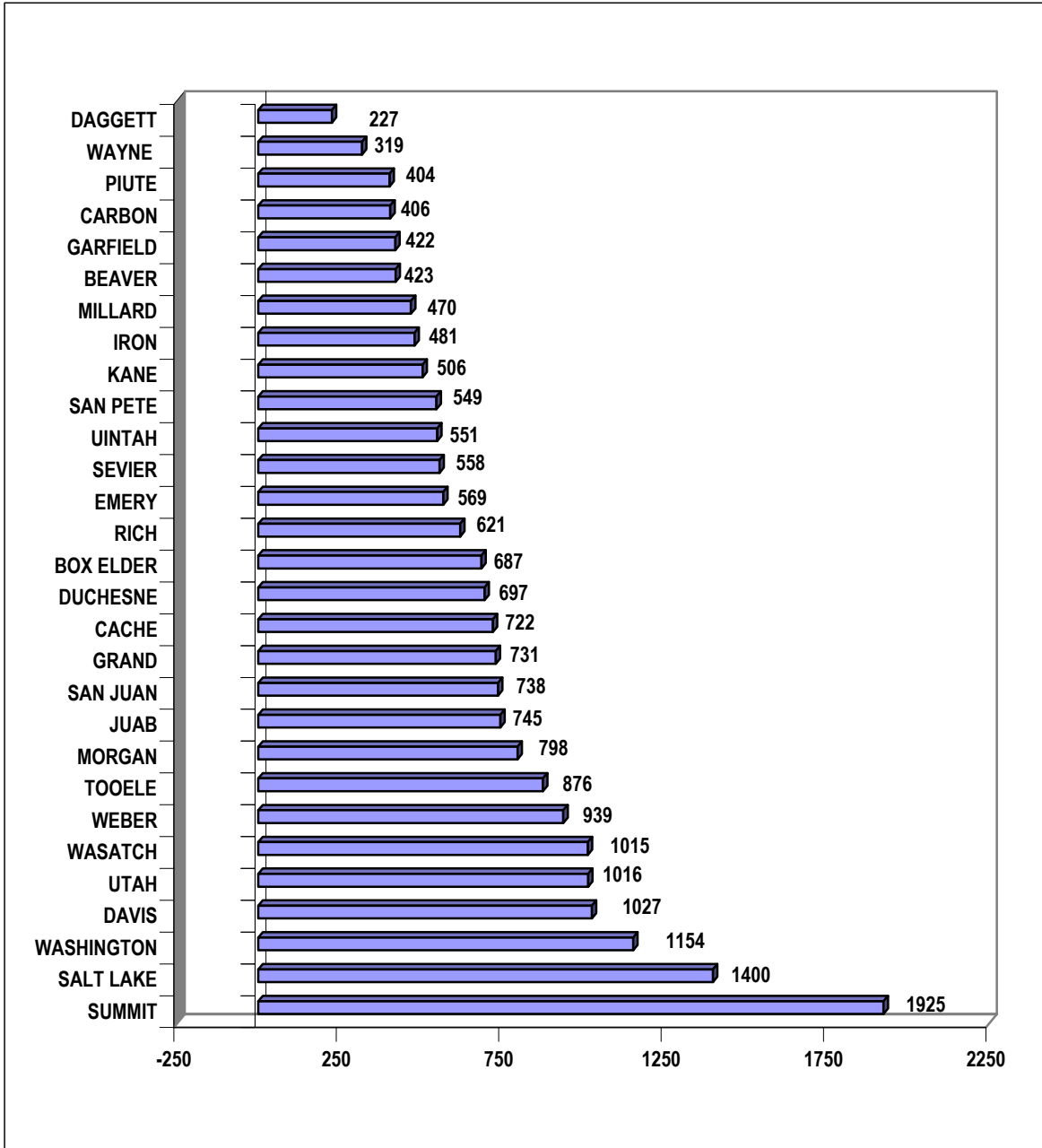

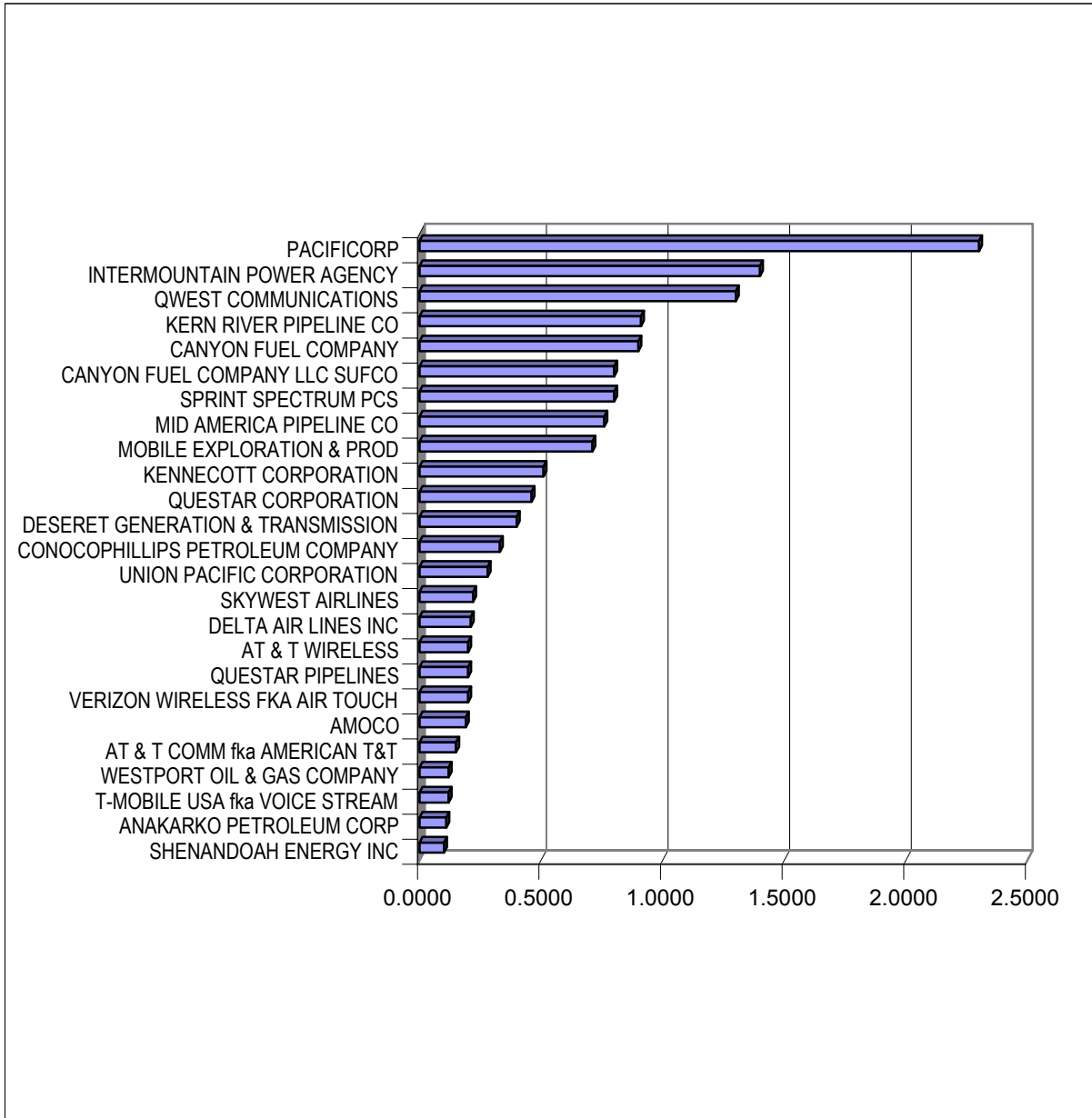

STATEWIDE TAX RELIEF BY CATEGORY FOR 2002

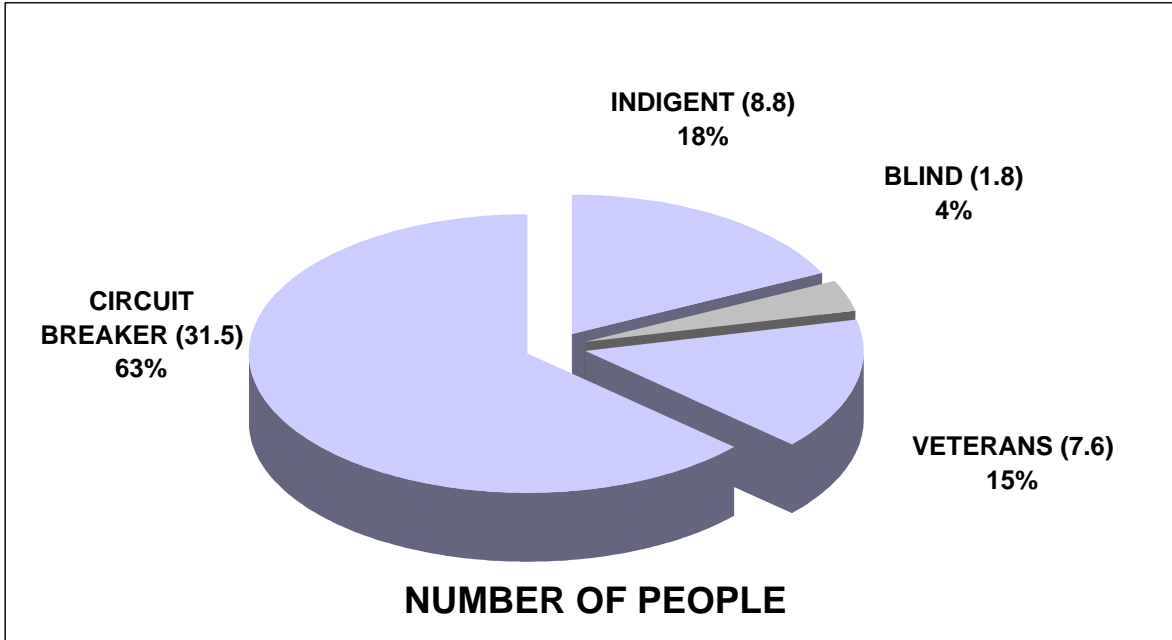
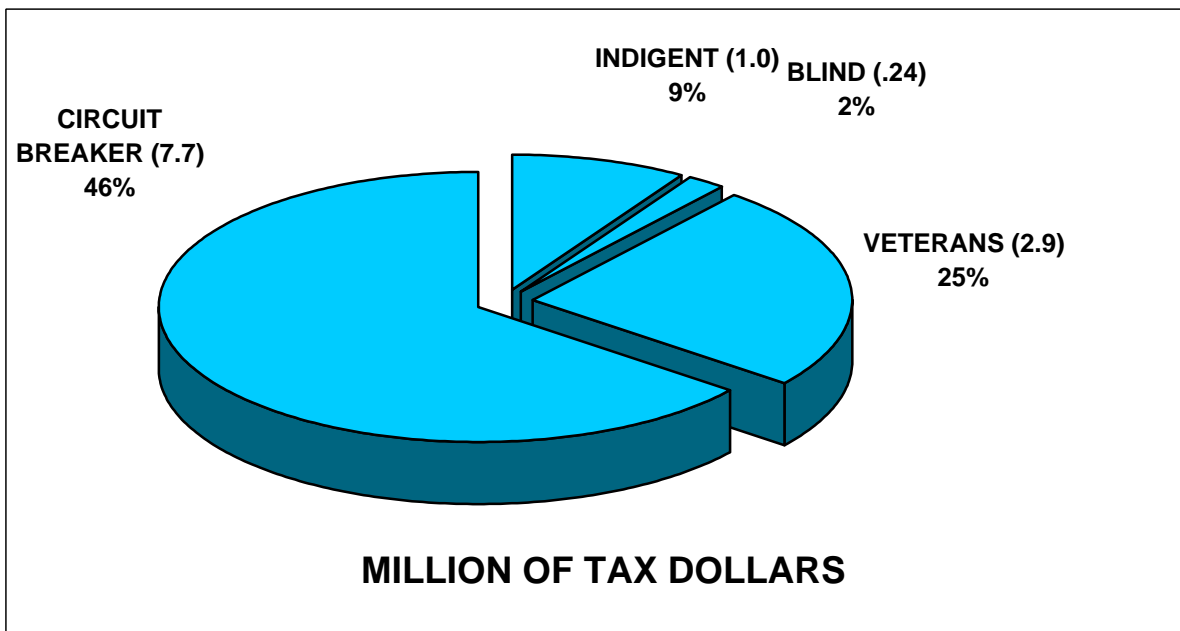
