AN ORDINANCE DECLARING THE ANNEXATION OF TERRITORY TO THE MUNICIPALITY OF WASHINGTON CITY

WHEREAS, the petition for Annexation known as the *Moore Addition* was approved by the City Council on May 14, 2008; and

WHEREAS, the petition for Annexation was certified by the City Recorder on March 26, 2008; and

WHEREAS, a Public Hearing was held on May 14, 2008; and

WHEREAS, Washington City feels that the statutory regulations of the Utah Code Annotated were complied with; and

THEREFORE, IT IS HEREBY ORDAINED by the City Council of Washington City, Utah, that the territory described below is hereby declared to be annexed into the Municipality and shall be zoned RA-1.
