

# Hearing Officer Requirements

County boards of equalization may appoint individuals to act as hearing officers for the purpose of examining an applicant or a witness. Hearing officers must meet the following minimum qualifications:

1. Be a licensed real estate appraiser through the Division of Real Estate, or be competent in the work of a hearing officer, including competency in real estate, finance, economics or law.
2. Complete a course that is developed or approved by the Tax Commission. [Utah Code Section 59-2-1001(3)]

The determination of whether a hearing officer candidate meets the 1st minimum requirement is up to the individual jurisdiction that appoints a hearing officer.

Two courses have been approved by the Tax Commission to meet the 2nd minimum requirement: 1) The Tax Commission's 4-hour Course 43, County Board of Equalization Hearing Officer Training, and 2) Salt Lake County's 10-hour Hearing Officer Training Course. Following is a list of individuals who have completed one of these courses as of 07/28/2020.
